- Submitting the F&R School Meals Household Application for approval is not applicable to SFAs that have implemented the Community Eligibility Provision (CEP) district wide.
- SFAs with year-round schools should submit renewal documents and information as soon as possible in order to complete the entire agreement renewal process by the deadline, **June 1, 2018**.

Procedures for Production Record Variances

As you renew your Annual Agreement in the SN Technology System for the 2018-19 school year, remember, if you are using any variance to the NCDPI Production Record (PR), it must be approved annually by your Zone Nutrition Specialist. Examples of a variance include a software format such as one from Meals Plus, NutriKids, Webtrition OR if you have modified the NCDPI PR to better meet the needs of your SFA.

In the site level applications questions **A7** and **B7** ask if you are planning to use the NC Production Record:

Q. Will the prototype Food Production Record provided by NCDPI be used? Yes No

If No, submit a copy of the production record to NCDPI for approval prior to use.

If no, is this production record different from the form used in all schools? Yes No N/A

If you answer NO to the first question:

1. Contact your Zone Nutrition Specialist and request a variance.
2. Complete the Daily Meal Production Record Variance Request form. Using the checklist, compare all of the criteria to your alternative PR, marking Yes if the criteria is included, or NO if it is missing and explain the justification in the comments field.
3. Send a copy of the completed form, customized instructions to complete the alternative production record and a sample breakfast and lunch PR to your Zone Nutrition Specialist.

Upon approval of the Daily Meal Production Record Variance, your Nutrition Specialist will upload the approval form into your Annual Agreement in the SN Technology System under Checklist Summary, Food Production Record. Please **DO NOT** upload sample production records. The Nutrition Specialist keeps these on file for reference throughout the year by reviewers.

Please contact your Zone Nutrition Specialist if you need to request a variance.

USDA Allows Low-Fat (1%) Flavored Milk Back into Schools – Act Now to Update Procurement Specifications for Next Year

Effective July 1, 2018 and beginning with the 2018-19 school year, the Interim Final Rule (IFR) issued by the US Department of Agriculture (USDA) allows program operators in the National School Lunch Program (NSLP), School Breakfast Program (SBP), Special Milk Program (SMP) and Child and Adult Care Food Program (CACFP) to offer flavored, low fat (1%) milk as part of a reimbursable meal for students in **grades K–12** and students in

CACFP (**ages 6 years and older**). Schools may also offer flavored, low-fat (1%) milk as a beverage when sold a la carte to students in these grade/age groups. This optional flexibility expands the variety of milk available to students in the meal programs which is intended to encourage children's consumption of fluid milk nationwide. Please remember all programs must offer at least two varieties of milk to students at all times.

No waivers are required to implement this voluntary provision in the NSLP, SBP, SMP. SFAs may modify their menus to reflect student preferences for low-fat flavored milk. Please remember to adjust specifications for new bids in your procurement documents to reflect this recent flexibility, which is intended to promote student meal satisfaction and ultimately, participation in the school meal programs.

Q&A: Uniform Grants Regulations and Procurement

Question: Are School Nutrition programs required to comply with the new Uniform Grants Regulations as they pertain to the procurement of goods and services? Someone in our LEA recently read a document that suggested School Nutrition Programs may be exempt from these regulations.

Answer: Yes, School Nutrition Programs, as sub-recipients of Federal funds, must comply with Uniform Grants regulations located at 2 CFR 200.317-326 in the procurement of goods and services in the School Nutrition Programs. The Uniform Grants regulations are included in the recent Procurement Plan template issued by the School Nutrition Section, so no further action is required other than to (1) complete and/or modify the template to reflect the SFA's actual procurement practices (fill in the blanks and provide specific details as needed), (2) obtain approval of the SFA's Procurement Plan approved by the governing body (Board of Education or Board of Directors) and (3) follow the plan when purchasing goods and services using School Nutrition funds.

NC Jr. Chef Competition Results

The Caliente Cowboys and Cowgirl from Clyde A. Erwin High in Buncombe County took first place in the first-ever NC Jr. Chef Competition with their Hot Asheville Chicken with Farmers Market Salad. Ashe County High School won second place with their Chicken and Cheese Enchiladas. Topsail High in Pender took third with their Tropical Chicken Wrap.

These high school students were challenged to work with their Family and Consumer Sciences teachers and School Nutrition directors to develop a creative recipe for a school lunch entrée that meets the National School Lunch Program nutrition standards, includes at least two North Carolina-grown products and one USDA Foods item, is replicable by School Nutrition Programs, and meets student taste-test preferences. During the cook-off, the teams prepared, cooked and presented their recipes for a panel of judges. Students showcased their creativity and culinary skills with all teams receiving either a gold or silver medal. In addition to the top three

teams who received gold medals, Parkwood High in Union County received gold. West Carteret High in Carteret County, East Mecklenburg High in Charlotte-Mecklenburg school district and East Gaston and Hunter Huss High in Gaston County all received silver medals. Congratulations to all of the teams!

The first-place team will advance to the Southeast Jr. Chef Competition May 9-10 at Sullivan University in Kentucky. As awards, Sullivan is offering the following scholarships to attend their university to each student team member:

- N.C. Jr. Chef Competition: 1st place - \$16,000, 2nd place - \$10,000, 3rd place - \$6,000
- Southeast Jr. Chef Competition: 1st place - full tuition and fees (value of \$45,000 - \$55,000 each), 2nd place - tuition (value of \$47,000 each), 3rd place - \$20,000 scholarship

The School Nutrition Services Section and Career and Technical Education Division at NCDPI partnered with NCDA&CS, NC FCCLA, and the Farm to School Coalition of NC to plan the first NC Jr. Chef Competition. Blue Cross and Blue Shield of North Carolina, the North Carolina Chapter of Les Dames d'Escoffier and the School Nutrition Association of North Carolina have provided generous support.

Recipes from the cook-off will be made available. Students are encouraged to work with their local School Nutrition Program to feature their recipes on future school menus.
